Subject/Focus:

KSDEM Douglas County Local Emergency Planning Commission (LEPC) oversight

Objective/Vision:

Authorize independent assessment of Wakarusa Wetlands HazMat spill impact zones.

Present/Situation:

Missing Failure Mode and Effects Analysis (FMEA) of avoidable mass casualty incidents from secondary & subsequent effects of South Lawrence Trafficway (SLT) HazMat spills.

Proposed/Solution:

Adapt DHS-KSDEM ESRI-GIS methodologies to simulate lead-times needed to safely evacuate Haskell Indian Nations University Campus and USD 497 schools within 2 miles of Broken Arrow Park. Then, repeat assuming SLT is rerouted south of Wakarusa River.

Advantages/Benefits (5):

Breaks *Cycles of Mistrust* that perpetuates ethnocide.
Enables effective *High-TEK* group decision support systems.
Applies previously proven anticipatory thinking practices.
Empowers prudent person principle (fiduciary responsibility).
Enforces maritime law's (inland waterway) *General Prudential Rule*.

Disadvantages/Hassles (3):

Amplifies Kansas Supreme Court *Golden Case Ruling* plausible deniability practices. May be exposed to further socio-economic/political manipulation. Discloses total costs & consequences over project's full lifecycle.

Action/Next Steps:

Contact Director of Douglas County's Local Emergency Planning Commission Establish urgent timeline for completing prerequisite and supporting tasks ... Notify DHS/FBI KC Division WMD Coordinator of problem escalation practices.
